They usually highlight the areas that will be approved or declined ahead of time so it's easy.







Bandago Rep Will Walk You Out to the Vans

*Take note: The code for the gate is #1957 to get back in after hours.

Once in the parking lot, the rep will pull the van out and walk around the vehicle marking down on the paperwork where there is damage. After you look over the van and agree about the previous damage, you can sign the papers.

Notice where the vans are parked in the far right corner of the lot and return them there during drop off. The only time this may be an issue is between 5-10pm when it tends to fill up. In that case, park wherever you can. It's not a problem!

To get out of the gate on foot, push black button on the top left corner of this box.
